Booking deposits are credited against the base rental charge, and are NON refundable. All reservations are final. Within 30 days of departure, the remaining balance will be charged to your credit card; reservations made within 30 days of departure must be paid in full at the time of booking. Cancellations of reservations within 30 days of departure (not including day of departure) are **nonrefundable**. The security deposit must be cleared the day prior to departure or the RV will not be allowed to depart. If the RV is returned in the condition it was rented, your deposit will typically be released within 10 business days. If damages are noted prior to or within the 10 days after your return, we reserve the right to collect and hold the deposit until damages are assessed / repaired and charged, with any applicable service charges, in full. We reserve the right to refuse and/or cancel a rental for any reason whatsoever to any applicant. If a rental is refused, the booking deposit will be refunded, with our liability limited to any funds received.
